AN ORDINANCE REVERTING THE AMOUNT OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM "OTHER MAINTENANCE & OPERATING EXPENSES (TRANSFER OF LAND TITLES)" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OTHER MAINTENANCE AND OPERATING EXPENSES (DEMOLITION COST)" IN THE OFFICE OF THE CITY MAYOR – SPECIAL PURPOSE LUMP SUM APPROPRIATIONS (SPA), CITY GOVERNMENT OF BACoor, CAVITE FOR CALENDAR YEAR 2019.

WHEREAS, submitted for review and approval is the proposed reversion of funds under the "Other Maintenance and Operating Expenses(Transfer of Land Titles)" to "Other Maintenance and Operating Expenses (Demolition Cost)" under the budget of the City Mayor's Office - Special Purpose Lump Sum Appropriations covered by the Annual General Fund Budget for Calendar Year 2019;

WHEREAS, there is a need to revert the amount of Five Million Pesos (Php5,000,000.00) from "Other Maintenance and Operating Expenses (Transfer of Land Titles)" to the "Other Maintenance and Operating Expenses (Demolition Cost)" under the Office of the City Mayor- Special Purpose Lump Sum Appropriations to be able to provide fund for the demolition cost for old Regional Trial Court building, to wit:

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the reversion of funds amounting to Five Million Pesos (Php 5,000,000.00) from "Other Maintenance & Operating Expenses (Transfer of Land Titles)" to the payment of expenses to be incurred under the "Other Maintenance and Operating Expenses (Demolition Cost)" in the Office of the City Mayor – Special Purpose Lump Sum Appropriations (SPA), City Government of Bacoor, Cavite for Calendar Year 2019.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of Five Million Pesos (Php5,000,000.00) for the "Other Maintenance and Operating Expenses (Demolition Cost)" under the budget of the Office of the City Mayor- Special Purpose Lump Sum Appropriations (SPA) for Calendar Year 2019;

Section 2. The above-mentioned amount of Five Million Pesos (Php5,000,000.00) shall be reverted from the "Other Maintenance & Operating Expenses (Transfer of Land Titles)" under the budget of the Office of the City Mayor- Special Purpose Lump Sum Appropriations (SPA) for Calendar Year 2019;


Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
