Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual Budget of Sangguniang Kabataan of various barangays to wit:

1. Niog III - Five Hundred Sixty Thousand Seven Hundred Ninety Four Pesos and 80/100 (Php 560,794.80) (Please see attached Sangguniang Kabataan Resolution No. 004 Series of 2019 dated February 9, 2019); and
2. Queens Row East - One Million Three Hundred Ninety Six Thousand Seven Hundred Ten Pesos and 50/100 (Php 1,396,710.50) (Please see attached Sangguniang Kabataan Resolution No. 001 dated January 26, 2019).


WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Mac Raven Espiritu duly seconded by Hon. Reynaldo D.
