BE IT ENACTED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled THAT:

Section 1. The purpose of this Ordinance is to appropriate the amount of Three Hundred Sixty Thousand Pesos (PhP360,000.00) for the "Fidelity Bond Premiums" and "Accountable Forms Expenses" under the budget of the Office of the City Treasurer for Calendar Year 2019;

Section 2. The above-mentioned amount of Three Hundred Sixty Thousand Pesos (PhP360,000.00) shall be reverted from the "Other Maintenance & Operating Expenses (Forum for Barangays)" under the budget of the Office of the City Treasurer for Calendar Year 2019;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
