AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF VARIOUS BARANGAYS IN THE CITY OF BACOOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual Budget of Sangguniang Kabataan of various barangays to wit:
