CITY ORDINANCE NO. CO 35-2019

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MABOLO II, CITY OF BACOOR, CAVITE AMOUNTING TO EIGHTY THOUSAND PESOS (PHP 80,000.00).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Mabolo II in the amount of **Eighty Thousand Pesos (Php 80,000.00)**. Attached is the Barangay Appropriation Ordinance No. 2019-001 Series of 2019 dated September 27, 2019

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Alde Joselito F. Pagulayan duly seconded by Hon. Victoria L. Guerrero, Jr. in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Mabolo II provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED LASTLY, this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
