AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY PANAPAAN IV, CITY OF BACOR, CAVITE AMOUNTING TO FOUR HUNDRED EIGHTY THOUSAND PESOS (PHP 480,000.00).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Panapaan IV in the amount of **Four Hundred Eighty Thousand Pesos (Php 480,000.00)**.
