AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY PANAPAAN I IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Budget of Sangguniang Kabataan of Barangay Panapaan I in the amount of Four Hundred Forty One Thousand Six Hundred Eighty Seven Pesos and 10/100 (Php 441,687.10).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Leandro A. De Leon in its regular session assembled, **HEREBY ORDAINED AS IT IS** HEREBY ORDAINED, by the Sangguniang Panlungsod to approve the Annual Budget of Sangguniang Kabataan of Barangay Panapaan I provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.


