AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY SAN NICOLAS II, CITY OF BACOOR, CAVITE AMOUNTING TO EIGHT HUNDRED THOUSAND PESOS (PHP 800,000.00).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay San Nicolas II in the amount of **Eight Hundred Thousand Pesos (Php 800,000.00)**. Attached is the Barangay Appropriation Ordinance No. 01 Series of 2019 dated September 11, 2019

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Michael E. Solis in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay San Nicolas II provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish the Office of the Local Chief Executive, the Punong Barangay of Barangay San Nicolas II and others concerned with copies of this Ordinance for their information and guidance.


ORDAINED LASTLY, this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
