**AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF VARIOUS BARANGAYS IN THE CITY OF BACOR, PROVINCE OF CAVITE.**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual Budget of Sangguniang Kabataan of various barangays to wit:

1. Molino VI – One Million Four Hundred Fifty Four Thousand Four Hundred Twenty Two Pesos and 40/100 (Php 1,454,422.40) (Please see attached Sangguniang Kabataan Resolution No. 002 Series of 2019 dated February 16, 2019);
2. Bayanan – Nine Hundred Forty Thousand One Hundred Thirty Three Pesos and 69/100 (Php 940,133.69) (Please see attached Sangguniang Kabataan Resolution No. 001 dated February 16, 2019) and
