**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO VI AMOUNTING TO SEVEN HUNDRED EIGHTY THOUSAND PESOS (PHP 780,000.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of Barangay Molino VI in the amount of **Seven Hundred Eighty Thousand Pesos (Php 780,000.00)**.
