**CITY ORDINANCE NO. CO 49B-2019**  
**Series of 2019**

**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY Panapaan III AMOUNTING TO ONE HUNDRED SIXTY THOUSAND PESOS (PHP 160,000.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of Barangay Panapaan III in the amount of **One Hundred Sixty Thousand Pesos (Php 160,000.00)**. Please see attached is the Barangay Appropriation Ordinance No. 01 Series of 2019 dated September 2, 2019.

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena B. Mendiola duly seconded by Hon. Alejandro F.
