**AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY KAINGEN IN THE CITY OF BACoor, PROVINCE OF CAVITE.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Budget of Sangguniang Kabataan of Barangay Kaingen in the amount of Four Hundred Thousand One Hundred Fifty Five Pesos (Php 400,155.00). Please see attached is the Sangguniang Kabataan Resolution No.001 Series of 2019 dated February 25, 2019.
