AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY MOLINO V IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Budget of Sangguniang Kabataan of Barangay Molino V in the amount of Six Hundred Forty Four Thousand Eighty Pesos and 20/100 (Php 644,080.20). Please see attached is the Sangguniang Kabataan Resolution No. 001 Series of 2019 dated March 25, 2019.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Mac Raven Espiritu duly seconded by Hon. Reynaldo D. Palabrica in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod to approve the Annual Budget of Sangguniang Kabataan of Barangay Molino V provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Sangguniang Kabataan Chairman of Barangay Molino V and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
