CITY ORDINANCE NO. CO 55-2019

AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF VARIOUS BARANGAYS IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual Budget of Sangguniang Kabataan of various barangays to wit:

1. Mambog IV - Eight Hundred Fifty Thousand Eight Hundred Five Pesos and 40/100 (Php 850,805.40). Please see attached Sangguniang Kabataan Resolution No. 003 Series of 2019 dated January 20, 2019;
2. Maliksi I - Five Hundred Sixty Five Thousand Nine Hundred Seventy Nine Pesos and 80/100 (Php 565,979.80). Please see attached Sangguniang Kabataan Resolution No. 001 Series of 2019 dated March 1, 2019;
3. Panapaan VI - Four Hundred Thirty Two Thousand Nine Hundred Pesos and 70/100 (Php 432,900.70). Please see attached Sangguniang Kabataan Resolution No. 001 Series of 2019 dated March 22, 2019;
4. Mabolo II - Two Hundred Forty Three Thousand One Hundred Eighty Five Pesos and 60/100 (Php 243,185.60). Please see attached Sangguniang Kabataan Resolution No. 001 Series of 2019 dated March 20, 2019; and
5. Dulong Bayan - Six Hundred Eighty Two Thousand Thirty Two Pesos and 20/100 (Php 682,032.20). Please see attached Sangguniang Kabataan Resolution No. 001 dated February 15, 2019;

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena Bautista-Mendiola duly seconded by Hon. Reynaldo D. Palabrica in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod to approve the Annual Budget of Sangguniang Kabataan of Barangays Mambog IV, Maliksi I, Panapaan VI, Mabolo II and Dulong Bayan provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
