Palabrica in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of the following Barangays Mambog IV, Ligas III, Real I, Salinas III, Talaba I, Queens Row West, Molino IV, Talaba III, Niog I, Molino III, Panapaan VI, Mambog I, San Nicolas III, Queens Row Central, Panapaan I, Aniban I, Molino V, Panapaan II provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangays Mambog IV, Ligas III, Real I, Salinas III, Talaba I, Queens Row West, Molino IV, Talaba III, Niog I, Molino III, Panapaan VI, Mambog I, San Nicolas III, Queens Row Central, Panapaan I, Aniban I, Molino V, Panapaan II and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
