AN ORDINANCE AMENDING CITY ORDINANCE NO. CO 72-2020 ENTITLED: "AN ORDINANCE CREATING THE CITY EPIDEMIOLOGY AND SURVEILLANCE UNIT (CESU) UNDER THE CITY HEALTH OFFICE OF THE CITY OF BACoor, ESTABLISHING ITS DUTIES AND FUNCTIONS, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF".

WHEREAS, on 20 April 2020, the Sangguniang Panlungsod passed City Ordinance No. CO 72-2020 entitled: "An Ordinance Creating The City Epidemiology And Surveillance Unit (CESU) Under The City Health Office Of The City Of Bacoor, Establishing Its Duties And Functions, And Providing Penalties For Violations Hereof" pursuant to Section 8 of Republic Act No. 11332 (the "Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act");

WHEREAS, pursuant to Department of Budget Management Local Budget Circular No. 2009-92, Nurse II position reallocated to **Salary Grade 15** so there is a need to amend **Section 3 - Composition and Organization of the CESU** particular in the position of Nurse II with corresponding Salary Grade 14.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of the City of Bacoor THAT:

Section 1. Section 3 of City Ordinance No. CO 72-2020, "Composition and Organization of the CESU" is hereby amended and shall henceforth read as follows:

"Section 3. Composition and Organization of the CESU. The CESU shall be under the direct control and supervision of the City Health Officer and shall be comprised of the following personnel who must be appointed by the City Mayor and must have the following qualifications:
