**AN ORDINANCE APPROVING THE REALIGNMENT OF FUNDS OF BARANGAY PANAPAAN VIII IN THE CITY OF BACOOR, PROVINCE OF CAVITE.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the realignment of funds of Barangay Panapaan VIII in the amount of Four Hundred Fifty Eight Thousand One Hundred Eighty Nine Pesos and 80/100 (Php458,189.80) through its Barangay Appropriation Ordinance No. 2020-001 passed and approved on 07 July 2020.

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, on motion of Councilor Rowena Bautista-Mendiola seconded by Councilors Miguel N. Bautista, Alde Joselito F. Pagulayan, Roberto L. Advincula and Hernando C. Gutierrez in 18<sup>th</sup> regular online session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod to approve the realignment of funds of Barangay Panapaan VIII amounting to Four Hundred Fifty Eight Thousand One Hundred Eighty Nine Pesos and 80/100 (Php458,189.80) provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED FURTHER**, to furnish copies of this ordinance to the Office of the City Mayor, the Punong Barangay of Barangay Panapaan VIII and others concerned for their information and guidance.
