AN ORDINANCE REALIGNING THE AMOUNT OF SIX MILLION SEVEN HUNDRED THOUSAND PESOS (PHP 6,700,000.00) FROM THE "TRAINING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OTHER SUPPLIES" IN THE OFFICE OF THE CITY MAYOR - CITY COUNCIL FOR THE PROTECTION OF CHILDREN (CCPC), CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2020.

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
