AN ORDINANCE REALIGNING THE AMOUNT OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM THE "SALARIES AND WAGES, PERA, OTHER BONUSES AND ALLOWANCES (MID YEAR BONUS) AND RETIREMENT AND LIFE INSURANCE PREMIUMS" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "TERMINAL LEAVE BENEFITS" IN THE OFFICE OF THE CITY MAYOR, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2020.

NOW THEREFORE, upon motion of Hon. Rowena Baulista Mendiola seconded by all the councilors present in 24th regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Five Million Pesos (PhP5,000,000.00)** from the "Salaries and Wages, PERA, Other Bonuses and Allowances (Mid Year Bonus), and Retirement and Life Insurance Premiums" to the payment of expenses to be incurred under the "Terminal Leave Benefits" in the Office of the City Mayor, City Government of Bacoor, Cavite for Calendar Year 2020.

BE IT ENACTED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in 24th Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of **Five Million Pesos (PhP 5,000,000.00)** for the "Terminal Leave Benefits" under the budget of the Office of the City Mayor for Calendar Year 2020;

Section 2. The above-mentioned amount of **Five Million Pesos (PhP5,000,000.00)** shall be realigned from the "Salaries and Wages, PERA, Other Bonuses and Allowances (Mid Year Bonus), and Retirement and Life Insurance Premiums" under the budget of the Office of the City Mayor for Calendar Year 2020;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
