AN ORDINANCE APPROVING THE REALIGNMENT OF FUNDS OF SANGGUNIANG KABATAAN OF VARIOUS BARANGAYS IN THE CITY OF BACOOR, PROVINCE OF CAVITE.

1. Tabing Dagat – Two Hundred Forty Two Thousand Seven Hundred Sixty Seven Pesos and 64/100 (Php242,767.64) (Please see attached Appropriation Ordinance No. 2020-002, dated May 6, 2020); and
2. Aniban II – Two Hundred Seventy Thousand Pesos (Php270,000.00) (Please see attached Appropriation Ordinance No. 2020-002, dated August 3, 2020).

WHEREFORE, after thorough deliberation on the aforementioned Sangguniang Kabataan budget, on motion of Hon. Rowena Bautista Mendiola unanimously seconded by all the councilors present in its regular online session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the realignment of funds of Sangguniang Kabataan of Barangays Tabing Dagat and Aniban II provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
