**AN ORDINANCE APPROVING THE REALIGNMENT OF FUNDS OF SANGGUNIANG KABATAAN OF VARIOUS BARANGAYS IN THE CITY OF BACOOR, PROVINCE OF CAVITE.**

1. Talaba II – One Hundred Thirty Three Thousand Nine Hundred Thirty Nine Pesos (Php133,939.00) (Please see attached Appropriation Ordinance No. 2020-003, dated August 26, 2020);
2. Maliksi I – Two Hundred Thousand Pesos (Php200,000.00) (Please see attached Appropriation Ordinance No. 2020-002, dated August 14, 2020)
3. Zapote V – Three Hundred Sixty One Thousand Six Hundred Two Pesos and 35/100 (Php361,602.35.00) (Please see attached Appropriation Ordinance No. 2020-003, dated August 20, 2020).

**WHEREFORE**, after thorough deliberation on the aforementioned Sangguniang Kabataan budget, on motion of Hon.
