2. Real II – Three Hundred Twenty Four Thousand Five Hundred Sixty Pesos and 64/100 (Php324,560.64) (Please see attached Appropriation Ordinance No. 002-2020 dated August 23, 2020);

**WHEREFORE**, after thorough deliberation on the aforementioned Sangguniang Kabataan budget, on motion of Hon.
