AN ORDINANCE REALIGNING THE AMOUNT OF FIVE MILLION TWO HUNDRED FIFTY SIX THOUSAND FIVE HUNDRED SEVENTY TWO PESOS (PHP 5,256,572.00) FROM THE "TRAINING EXPENSES AND "OTHER MAINTENANCE & OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OTHER SUPPLIES AND MATERIALS EXPENSES" IN THE ANNUAL BUDGET OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2020.

online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Five Million Two Hundred Fifty Six Thousand Five Hundred Seventy Two Pesos (PhP5,256,572.00)** from the "Training Expenses and "Other Maintenance & Operating Expenses" to the payment of expenses to be incurred under the "Other Supplies And Materials Expenses" in the Annual Budget of the City Social Welfare and Development Office, City Government of Bacoor, Cavite for Calendar Year 2020.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of **Five Million Two Hundred Fifty Six Thousand Five Hundred Seventy Two Pesos (PhP5,256,572.00)** for the "Other Supplies and Materials Expenses" under the budget of the City Social Welfare and Development Office for Calendar Year 2020;

Section 2. The above-mentioned amount of **Five Million Two Hundred Fifty Six Thousand Five Hundred Seventy Two Pesos (PhP5,256,572.00)** shall be realigned from the "Training Expenses" and "Other Maintenance & Operating Expenses" under the budget of the City Social Welfare and Development Office for Calendar Year 2020;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
