AN ORDINANCE REALIGNING THE AMOUNT OF ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PHP 1,250,000.00) FROM THE "TRAINING EXPENSES", "OTHER MAINTENANCE & OPERATING EXPENSES (CHILDREN PROTECTION ACTIVITIES)" AND "OTHER MAINTENANCE & OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "DRUGS AND MEDICINE" IN THE ANNUAL BUDGET OF THE CITY HEALTH OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2020.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the rest of the council in 29th regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **One Million Two Hundred Fifty Thousand Pesos (PhP1,250,000.00)** from the "Training Expenses", "Other Maintenance & Operating Expenses (Children Protection Activities)" and "Other Maintenance & Operating Expenses" to the payment of expenses to be incurred under the "Drugs and Medicines" in the budget of the City Health Office, City Government of Bacoor, Cavite for Calendar Year 2020.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of **One Million Two Hundred Fifty Thousand Pesos (PhP1,250,000.00)** for the "Drugs and Medicines" under the budget of the City Health Office for Calendar Year 2020;

Section 2. The above-mentioned amount of **One Million Two Hundred Fifty Thousand Pesos (PhP1,250,000.00)** shall be realigned from the "Training Expenses", "Other Maintenance & Operating Expenses (Children Protection Activities)" and "Other Maintenance & Operating Expenses" under the budget of the City Health Office for Calendar Year 2020;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
