CITY ORDINANCE NO. CO 143-2020

AN ORDINANCE GRANTING A ZERO PER CENT (0%) TAX RATE ON LOCAL BUSINESS TAXES FOR COMPANIES ENGAGED IN PROJECTS CERTIFIED BY THE JAPANESE EMBASSY AND FUNDED BY THE JAPAN OFFICIAL DEVELOPMENT ASSISTANCE (JAPAN-ODA) IN THE CITY OF BACORR REGARDING THE LRT 1 SOUTH (CAVITE) EXTENSION PROJECT.

WHEREAS, the national government is set to begin construction of the LRT 1 South (Cavite) Extension Project that will link the City of Bacoor, Cavite to the City of Parañaque and the rest of Metro Manila through various Light Rail Transit 1 stations.

WHEREAS, the said project, once completed, is expected to reduce economic losses caused by traffic gridlock and greatly decrease travel time from the province of Cavite to various points in Metro Manila.

WHEREAS, the Japanese government provided substantial financial and technical support for the successful and speedy implementation of the project through the Japan Official Development Program (Japan-ODA).

WHEREAS, the Office of the City Mayor requested the Sangguniang Panlungsod to pass an ordinance granting tax relief to various companies to be certified by the Japanese Embassy in Manila that will take part in the construction of the said project namely: 1) Mitsubishi Corporation; 2) Marubeni-DMCI Consortium and 3) Shimitzu Corporation.

WHEREAS, the Committee on Finance, Budget and Appropriations, the Committee on Rules and Privileges, Laws and Ordinances, and the Committee on Peace and Order and Public Safety conducted a public hearing on the said

request on 27 November 2020 and jointly recommended the approval of the proposed incentive ordinance considering that the said project is in keeping with bilateral commitments entered into by the Philippine Government with the Japanese Government and will redound to the benefit of the general public.

NOW, THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular online session duly assembled **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod that:

Section 1. Title. This Ordinance shall be known and referred to as the **"Japanese Official Development Assistance Incentive Ordinance of the City of Bacoor"**.

Section 2. Grant of Tax Relief. A zero percent (0%) tax rate shall be imposed on all local business taxes in favor of the following private companies 1) Mitsubishi Corporation; 2) Marubeni-DMCI Consortium and 3) Shimizu Corporation. **Provided that:** the said incentive can only be availed of by the said companies for business transactions related to the LRT 1 South (Cavite) Extension Project as certified by the Japanese Embassy. **Provided further that:** the said tax incentive cannot be used for projects not certified by the Japanese Embassy in Manila. **Provided lastly that:** the said tax relief shall automatically cease upon completion of the LRT 1 South (Cavite) Extension Project as certified by the Light Railway Transit Authority, the Department of Transportation, or any other national government agency authorized by law to issue such a certification.

Section 3. Repeal. All ordinances, resolutions, and executive orders inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect ten (10) days from the date a copy hereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) conspicuous places in the City of Bacoor not later than five (5) days after approval thereof. A copy of this Ordinance shall also be published once in a newspaper of general circulation in the Province of Cavite.

Section 5. Dissemination. The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Bureau of Local Government Finance (BLGF), the Department of Transportation (DoTr), the Office of the City
