APPROPRIATION ORDINANCE NO. CO 144-2020
SERIES OF 2020

AN ORDINANCE REALIGNING THE AMOUNT OF SIX MILLION PESOS (PHP 6,000,000.00) FROM THE "DONATIONS-SCHOLARSHIP PROGRAM"; "DONATIONS - AID TO ATHLETES" AND "DONATIONS- HOSPITALIZATION PROGRAMS" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "DONATIONS- PAUPER'S BURIAL ASSISTANCE" IN THE OFFICE OF THE CITY MAYOR, AND REALIGNING THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (PHP300,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES " TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "FIDELITY BOND PREMIUMS" IN THE OFFICE OF THE CITY TREASURER, CITY GOVERNMENT OF BACoor, CAVITE FOR CALENDAR YEAR 2020.

WHEREAS, submitted for review and approval are 1) the proposed realignment of funds from the "Donations-Scholarship Program"; "Donations-Aid to Athletes"; and "Donations-Hospitalization Programs" to the payment of expenses to be incurred under the "Donations-Pauper's Burial Assistance" under the budget of the Office of the City Mayor and 2) the proposed realignment of funds from the "Other Maintenance and Operating Expenses" to the payment of expenses to be incurred under "Fidelity Bond Premiums" under the budget of the Office of the City Treasurer both covered by the Annual General Fund Budget for Calendar Year 2020;

WHEREAS, there is a need to realign the amount of **Six Million Pesos (Php6,000,000.00)** from the "Donations - Scholarship Programs"; "Donations - Aid to Athletes"; and "Donations - Hospitalization Programs" to the "Donations - Pauper's Burial Assistance" under the Office of the City Mayor to be able to provide additional funding for payment of burial assistance for indigent individuals.

to Athletes"; and "Donations – Hospitalization Programs" to the payment of expenses to be incurred under the "Donations-Pauper's Burial" in the Office of the City Mayor; and 2) the realignment of funds amounting to **Three Hundred Thousand Pesos (Php300,000.00)** from the "Other Maintenance and Operating Expenses" to the payment of expenses to be incurred under the "Fidelity Bond Premiums" in the Office of the City Treasurer, City Government of Bacoor, Cavite for Calendar Year 2020.

BE IT ENACTED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in 36th Regular Online Session assembled THAT :

Section 1. The purposes of this Ordinance are: 1) to appropriate the amount of **Six Million Pesos (Php6,000,000.00)** for the "Donations –Pauper's Burial Assistance" under the budget of the Office of the City Mayor for Calendar Year 2020; and 2) to appropriate the amount of **Three Hundred Thousand Pesos (Php300,00.00)** for the "Fidelity Bond Premiums" under the budget of the Office of the City Treasurer for Calendar Year 2020 ;

Section 2. The amount of **Six Million Pesos (Php6,000,000.00)** shall be realigned from the "Donations-Scholarship Program"; "Donations-Aid to Athletes"; and "Donations-Hospitalization Programs" under the budget of the Office of the City Mayor for Calendar Year 2020 and the amount of **Three Hundred Thousand Pesos (Php300,00.00)** shall be realigned from "Other Maintenance and Operating Expenses" under the budget of the Office of the City Treasurer for Calendar Year 2020;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.

Section 5. The Sangguniang Panlungsod Secretariat is hereby directed to submit certified true copies of this Ordinance to the University of the Philippines-Office of the National Administrative Register pursuant to Section 3, Book VII of the Administrative Code of 1987 (E.O. 292).
