NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the rest of the council in regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Two Hundred Thousand Pesos (PhP200,000.00)** from the "Training Expenses" to the payment of expenses to be incurred under the "Other Professional Services (Honoraria)" in the budget of the City Mayor's Office, City Government of Bacoor, Cavite for Calendar Year 2020.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of **Two Hundred Thousand Pesos (PhP200,000.00)** for the "Other Professional Services (Honoraria) " under the budget of the City Mayor's Office for Calendar Year 2020;

Section 2. The above-mentioned amount of **Two Hundred Thousand Pesos (PhP200,000.00)** shall be realigned from the "Training Expenses" under the budget of the City Mayor's Office for Calendar Year 2020;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.
