**AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF BARANGAY MOLINO III IN THE CITY OF BACOOR.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual General Fund Budget of Barangay Molino III in the amount of Forty Seven Million Three Hundred Thirty Four Thousand Six Hundred Eighty Two Pesos (Php47,334,682.00).

**ORDAINED FURTHER**, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangay Molino III and others concerned for their information and guidance.

**ORDAINED LASTLY**, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.







