Section 4. Creation of Special Account in the General Fund. Pursuant to Local Budget Circular No. 125 (dated 7 April 2020) of the Department of Budget and Management, a Special Account in the General Fund (SAGF) of the Annual Budget of the City of Bacoor is hereby created in order to facilitate the monitoring/tracking of the utilization of the Bayanihan Grant for Cities and Municipalities (BGCM) amounting to **Php113,907,246.00**.

Section 5. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 6. Effectivity. The provisions of this Ordinance shall take effect upon its approval.
