**AN ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION FOUR HUNDRED THOUSAND PESOS (PHP 3,400,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES (LIBRENG SINE PROGRAM)" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "DONATIONS (KALINGA SA MATATANDA/PWDs)" IN THE OFFICE OF THE CITY MAYOR, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2020.**

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista Mendiola seconded by all the councilors present in 6<sup>th</sup> regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Three Million Four Hundred Thousand Pesos (Php 3,400,000.00)** from the "Other Maintenance & Operating Expenses (Libreng Sine Program)" to the payment of expenses to be incurred under the "Donations (Kalinga sa Matatanda/PWDs)" in the Office of the City Mayor, City Government of Bacoor, Cavite for Calendar Year 2020.

**BE IT ENACTED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite in 6<sup>th</sup> Regular Online Session assembled THAT :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of **Three Million Four Hundred Thousand Pesos (PhP3,400,000.00)** for the "Donations (Kalinga Sa Matatanda/PWDs)" under the budget of the Office of the City Mayor for Calendar Year 2020;

**Section 2.** The above-mentioned amount of **Three Million Four Hundred Thousand Pesos (PhP3,400,000.00)** shall be realigned from the "Other Maintenance and Operating Expenses (Libreng Sine Program)" under the budget of the Office of the City Mayor for Calendar Year 2020;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** This Appropriation Ordinance shall take effect upon its approval.
