ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangays Bayanan, Salinas I, Zapote III, Mambog III, Mambog II, Aniban IV, Molino VI, Molino VII, Tabing Dagat, Daang Bukid, Maliksi II and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately upon its approval and upon posting on the website of the Sangguniang Panlungsod (www.bacoorcitysp.com) of the City of Bacoor.
