4. San Nicolas III – Six Hundred Thousand Pesos (Php600,000.00) (Please see attached Appropriation Ordinance No. 2020-001, dated May 6, 2020);

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of








