- San Nicolas II – Four Hundred Fifty Six Thousand Eight Hundred Twenty Nine Pesos and 21/100 (Php456,829.21) (Please see attached Appropriation Ordinance No. 2020-002, dated May 11, 2020);
- Molino IV – One Million Two Hundred Ninety Six Thousand Four Hundred Pesos and 53/100 (Php1,296,400.53) (Please see attached Appropriation Ordinance No. 02, Series of 2020 dated June 1, 2020); and
- Daang Bukid - One Hundred Seventy Nine Thousand Three Hundred Sixty Two Pesos and 80/100 (Php179,362.80) (Please see attached Appropriation Ordinance No. 2020 002, dated May 28, 2020);

WHEREFORE, after thorough deliberation on the aforementioned Sangguniang Kabataan budget, on motion of Hon. Rowena Bautista Mendiola unanimously seconded by all the councilors present in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the realignment of funds of Sangguniang Kabataan of Barangays Aniban IV, Mambog V, Aniaban I, Zapote I, Talaba II, San Nicolas III, San Nicolas II, Molino IV and Daang Bukid provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the SK Chairperson of Barangays Aniban IV, Mambog V, Aniaban I, Zapote I, Talaba II, San Nicolas III, San Nicolas II, Molino IV, Daang Bukid and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately upon its approval and upon posting on the website of the Sangguniang Panlungsod (www.bacoorcitersp.com) of the City of Bacoor.
