7. Talaba VII – Two Hundred Seventy Nine Thousand Eight Hundred Forty Pesos and 01/100 (Php279,840.01) (Please see attached Appropriation Ordinance No. 2020-002, dated May 29, 2020).

WHEREFORE, after thorough deliberation on the aforementioned Sangguniang Kabataan budget, on motion of Hon. Rowena Bautista Mendiola unanimously seconded by all the councilors present in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the realignment of funds of Sangguniang Kabataan of Barangays Queen's Row East, Talaba VI, Zapote IV, Talaba IV, Mambog III, Sinaguelasan, and Talaba VII provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
