CITY ORDINANCE NO. CO 149-2021

AN ORDINANCE AUTHORIZING THE CITY DATA PRIVACY OFFICER (MANAGEMENT INFORMATION SYSTEM) AND REQUIRING OTHER RELEVANT SECTORS TO DISCLOSE REQUIRED INFORMATION FOR SUBMISSION TO THE DEPARTMENT OF HEALTH (DOH) COVID ELECTRONIC IMMUNIZATION REGISTRY FOR BACOOR IN CONNECTION WITH THE NATIONAL VACCINATION PROGRAM AGAINST COVID-19.

WHEREAS, on 22 January 2021, the Office of the City Legal Service sent a letter requesting the Sangguniang Panlungsod to pass a City Ordinance authorizing the designated City Data Privacy Officer of the city government to disclose various information required for submission to the Department of Health (DOH) COVID Electronic Immunization Registry for Bacoor in connection with the National Vaccination Program Against COVID-19.

WHEREAS, the approval of such an ordinance is among the requirements of the Department of Health (DOH) for the COVID Electronic Immunization Registry (CEIR) which is an integral part of the National Vaccination Program of the national government wherein various health facilities and other agencies, public and private, located within the jurisdiction of the City of Bacoor shall be required to comply with electronic registration and to submit pertinent personal data of the persons who will be vaccinated.

WHEREAS, the Management Information System (MIS) Office of the City of Bacoor has prepared a system for the collection of various data to be required from local health facilities.

WHEREAS, based on the said system, the City of Bacoor through the MIS, shall submit all data collected to the CEIR of the DOH Registration on various Bacooreños who will be vaccinated under the National Vaccination Program.

WHEREAS, the proposed ordinance is compliant with the requirements of Republic Act 10173 or the Data Privacy Act of 2012, particular under the following provisions:

"SEC. 11 General Data Privacy Principles. The processing of personal information shall be allowed, subject to compliance with the requirements of this Act and other laws allowing disclosure of information to the public and adherence to the principles of transparency, legitimate purpose and proportionality.

Personal information must be:

(a) Collected for **specified and legitimate purposes** determined and declared before, or as soon as reasonably practicable after collection and later processed in a way compatible with such declared, specified and legitimate purposes only;

(b) **Processed fairly and lawfully:**"

"SEC.12 Criteria for Lawful Processing of Personal Information. – The processing of personal information shall be permitted only if not otherwise prohibited by law, and when at least one of the following conditions exists:

- (a) The data subject has given his or her consent;
- (b) The processing of personal information is necessary and is related to the fulfillment of a contract with the data subject or in order to take steps at the request of the data subject prior to entering into a contract;
- (c) The processing is necessary for compliance with a legal obligation to which the personal information controller is subject;
- (d) The processing is necessary to protect vitally important interests of the data subject, including life and health;
- (e) **The processing is necessary in order to respond to national emergency, to comply with the requirements of public order and safety, or to fulfill functions of public authority which necessarily includes the processing of personal data for the fulfillment of its mandate;** or
- (f) The processing is necessary for the purposes of the **legitimate interests** pursued by the personal

information controllers or by a third party or parties to whom the data is disclosed, except where such interests are overridden by fundamental rights and freedoms of the data subject which require protection under the Philippine Constitution."

NOW, THEREFORE, upon motion of Hon. Josecito Alde F. Pagulayan duly seconded by Hon. Reynaldo D. Palabrica in regular online session duly assembled **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod that:

Section 1. Title. This Ordinance shall be known and referred to as the **"DOH COVID Electronic Immunization Registry Ordinance of the City of Bacoor"**.

Section 2. Grant of Authority. This is to authorize the designated City Data Privacy Officer of the City of Bacoor and other relevant sectors to disclose the various personal information of persons to be vaccinated within the City of Bacoor, Cavite for submission to the Department of Health (DOH) COVID Electronic Immunization Registry (CEIR) for Bacoor in connection with the City Vaccination Plan and in compliance to the National Vaccination Cluster of the National Task Force Against COVID-19.

Section 3. Limitations on Authority. The authority above granted shall only be for the purpose mentioned above and shall not include the authority to share, sell, distribute, or publish any of the personal data above intimated to any third party without the express, written consent of the person/s owning the said data.

Section 4. Penalties. The following penalties shall be imposed against any person who violates this Ordinance, or who fails to comply with the various requirements of the DOH in relation to the implementation and establishment of the CEIR:

First Offense: Payment of fine amounting to P3,000.00 plus rendition of community service to be determined by the appropriate court of law for a period not exceeding 30 days.

Second Offense: Payment of fine amounting to P4,000.00 plus rendition of community service to be determined by the appropriate court of law for a period not exceeding 60 days.



appropriate court of law for a period not exceeding 90 days.

Section 5. Repeal. All ordinances, resolutions, and executive orders inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity. This ordinance shall take effect ten (10) days from the date a copy hereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) conspicuous places in the City of Bacoor not later than five (5) days after approval thereof. A copy of this Ordinance shall also be published once in a newspaper of general circulation in the Province of Cavite.

Section 7. Dissemination. The Sangguniang Panlungsod Secretariat is hereby directed to furnish Management Information System Office, the Department of Health (DOH), the Office of the City Legal Service, the City Health Office, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and all government agencies and offices concerned with copies of this ordinance.






