AN ORDINANCE REORGANIZING THE CITY PLANNING AND
DEVELOPMENT COORDINATION OFFICE OF THE CITY OF
BACOR, CAVITE.

WHEREAS the City Planning and Development
Coordination Office would play a vital role in preparing the
City of Bacoor for a post-pandemic world and other future
challenges. However, it lacks certain plantilla positions that
would enable it to effectively fulfill its mandate. Thus, there is
a need to reorganize the CPDCO and transform it into a
more dynamic tool in future proofing the City of Bacoor,
Cavite.

WHEREAS, Article 163 of the Rules and Regulations
Implementing Republic Act No. 7160 provides that "the local
government unit shall design and implement its
organizational structure and staffing pattern taking into
consideration its priority needs, service requirements and
financial capabilities, consistent with the principles of
simplicity, efficiency, economy, effectiveness, dynamism and
public accountability subject to the minimum standards and
guidelines prescribed by the Civil Service Commission (CSC)".

NOW THEREFORE, BE IT ORDAINED by the 4th

Section 2. Creation of New Position at the CPDCO. In view of the abolition of the position of Economic Researcher in the immediately preceding section, the position of Clerk IV (SG-8) is hereby created at the City Planning and Development Coordination Office in accordance with existing civil service regulations.

Section 3. Renaming of Statistician III (SG-18) to Planning Officer III (SG-18). To widen the scope of the duties and responsibilities of the person to be hired by the city government for the position hereunder mentioned, the position title of "Statistician III" in the plantilla of the CPDCO is hereby renamed into "Planning Officer III" which would have a Salary Grade 18 (SG 18) in accordance with existing civil service regulations.

Section 4. Effectivity. This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.

Section 5. Separability. Any provision of this Ordinance declared void by any court of law shall not affect the other provisions hereof not affected by such declaration.

Section 6. Dissemination. The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Civil Service Commission, the Human Resource Development and Management Department, the Office of the City Budget Officer, the Office of the City Mayor, and all government offices concerned with copies of this ordinance immediately after its date of effectivity.
