**APPROPRIATION ORDINANCE NO. CO 173-2021

AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION PESOS (PHP 2,000,000.00) FROM THE "OTHER MACHINERY AND EQUIPMENT", TO THE PAYMENT OF CAPITAL OUTLAY TO BE INCURRED UNDER THE "INFORMATION AND COMMUNICATIONS TECHNOLOGY EQUIPMENT" IN THE ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR - (MANAGEMENT INFORMATION SYSTEM-MIS), CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2021.


BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :


