AN ORDINANCE REALIGNING THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS (PHP 1,200,000.00) FROM THE "TELEPHONE EXPENSES AND TELEPHONE EXPENSES (MOBILE)", TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "INTERNET SUBSCRIPTION EXPENSES" IN THE ANNUAL BUDGET OF THE BACOOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2021.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola seconded by Hons. Roberto L. Advincula, Miguel N. Bautista, Alejandro F. Gutierrez, and Gaudencio P. Nolasco in regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **One Million Two Hundred Thousand Pesos (PhP1,200,000.00)** from the "Telephone Expenses and Telephone Expenses (Mobile)" to the payment of expenses to be incurred under the "Internet Subscription Expenses" in the budget of the Bacoor Disaster Risk Reduction and Management Office, City Government of Bacoor, Cavite for Calendar Year 2021.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of **One Million Two Hundred Thousand Pesos (PhP1,200,000.00)** for the "Internet Subscription Expenses" under the budget of the Bacoor Disaster Risk Reduction and Management Office for Calendar Year 2021.

Section 2. The above-mentioned amount of **One Million Two Hundred Thousand Pesos (PhP1,200,000.00)** shall be realigned from the "Telephone Expenses and Telephone Expenses (Mobile)" under the budget of the Bacoor Disaster Risk Reduction and Management Office for Calendar Year 2021.

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above stated.






