AN ORDINANCE REALIGNING THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (PHP 800,000.00) FROM THE "ADVERTISING EXPENSES" AND "OTHER MAINTENANCE AND OPERATING EXPENSES", TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "ACCOUNTABLE FORMS EXPENSES" IN THE ANNUAL BUDGET OF THE OFFICE OF THE CITY TREASURER, CITY GOVERNMENT OF BACoor, CAVITE FOR CALENDAR YEAR 2021.

Solis in regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Eight Hundred Thousand Pesos (PhP800,000.00)** from the "Advertising Expenses" and "Other Maintenance and Operating Expenses" to the payment of expenses to be incurred under the "Accountable Forms Expenses" in the budget of the Office of the City Treasurer, City Government of Bacoor, Cavite for Calendar Year 2021.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate the amount of **Eight Hundred Thousand Pesos (PhP800,000.00)** for the "Accountable Forms Expenses" under the budget of the Office of the City Treasurer for Calendar Year 2021;

Section 2. The above-mentioned amount of **Eight Hundred Thousand Pesos (PhP800,000.00)** shall be realigned from the "Advertising Expenses" and "Other Maintenance and Operating Expenses" under the budget of the Office of the City Treasurer for Calendar Year 2021;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;


