AN ORDINANCE REALIGNING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (PHP 250,000.00) FROM THE "TRAINING EXPENSES" AND "REPAIRS & MAINTENANCE OF OFFICE EQUIPMENT" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "FIDELITY BOND PREMIUMS" IN THE ANNUAL BUDGET OF THE CITY TREASURER'S OFFICE AND REALIGNING THE AMOUNT OF THREE HUNDRED FIFTY THOUSAND PESOS (PHP350,000.00) FROM THE "ENVIRONMENTAL/SANITARY SERVICES (SANITARY SERVICES-CASH FOR WORK- KALINGA SA KALIKASAN AND BARANGAY ALERTO)" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "ENVIRONMENTAL/SANITARY SERVICES (HAULING OF HAZARDOUS WASTES)" IN THE ANNUAL BUDGET OF THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2021.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the rest of the council in regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve (1) the realignment of funds amounting to **Two Hundred Fifty Thousand Pesos (Php250,000.00)** from the "Training Expenses" and "Repairs & Maintenance of Office Equipment" to the payment of expenses to be incurred under the "Fidelity Bond Premiums" in the budget of the City Treasurer's Office; and 2) the realignment of funds amounting to **Three Hundred Fifty Thousand Pesos (Php350,000.00)** from the "Environmental/Sanitary Services (Sanitary Services-Cash For Work- Kalinga Sa Kalikasan and Barangay Alerto)" to the payment of expenses to be incurred under the "Environmental/Sanitary Services (Hauling of Hazardous Wastes)" in the budget of the City Environment and Natural Resources Office, City Government of Bacoor, Cavite for Calendar Year 2021.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

Section 1. The purpose of this Ordinance is to appropriate (1) the amount of **Two Hundred Fifty Thousand Pesos (Php250,000.00)** for the "Fidelity Bond Premiums " under the budget of the City Treasurer's Office; and (2) the amount of **Three Hundred Fifty Thousand Pesos (Php350,000.00)** for the "Environmental/Sanitary Services (Hauling of Hazardous Wastes)" under the budget of the City Environment and Natural Resources Office for Calendar Year 2021;

Section 2. The amount of **Two Hundred Fifty Thousand Pesos (Php250,000.00)** shall be realigned from the "Training Expenses" and "Repairs & Maintenance of Office Equipment" under the budget of the City Treasurer's Office - and the amount of **Three Hundred Fifty Thousand Pesos (Php350,000.00)** shall be realigned from the "Environmental/Sanitary Services (Sanitary Services-Cash For Work- Kalinga Sa Kalikasan and Barangay Alerto)" under the budget of the City Environment and Natural Resources Office for Calendar Year 2021;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at
