CITY ORDINANCE NO. CO 183-2021
Series of 2021

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. CO 150-2021, SERIES OF 2021 ENTITLED: "AN ORDINANCE ALLOWING PUBLIC UTILITY TRICYCLES OPERATING WITHIN THE CITY OF BACOR TO CARRY NOT MORE THAN TWO PASSENGERS AND TO CHARGE NOT MORE THAT FIFTEEN PESOS (PHP 15.00) PER PASSENGER DURING EACH TRIP AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF".

WHEREAS, on 8 March 2021, the Sangguniang Panlungsod passed City Ordinance No. CO 150-2021 entitled: "An Ordinance Allowing Public Utility Tricycles Operating Within The City Of Bacoor To Carry Not More Than Two Passengers And To Charge Not More That Fifteen Pesos (Php 15.00) Per Passenger During Each Trip And Providing Penalties For Violations Hereof".

WHEREAS, the Pinagkaisang TODA ng Ikalawang Distrito and the Federation TODA of the City of Bacoor petitioned the city council to amend Section 4 of the City Ordinance CO 150-2021;

WHEREAS, the said request was referred to the Committee on Government Enterprises and Privatization, Public Franchises, Committee on Rules, Privileges, Laws and Ordinances and Committee on Public Transportation and Traffic Management for further study and evaluation;

WHEREAS, the above-mentioned committees conducted online public hearings on the said petition and recommended to the Sangguniang Panlungsod to pass an ordinance granting the request of public utility tricycle drivers and operators, implementing measures to prevent the spread of the COVID-19 virus, and adjusting the tricycle fare rates per trip per passenger.

NOW, THEREFORE:

Be it ordained by the Sangguniang Panlungsod of Bacoor, Cavite in regular online session assembled that:

NOW THEREFORE, BE IT ORDAINED by the 4th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular online session duly assembled THAT:

Section 1. Section 4, of the City Ordinance No. CO 150-2021 is hereby amended and shall henceforth read as follows:

"Section 4. Minimum Fare. All PUTs covered by this Ordinance shall charge the following fares based on the following:

<u>No. of Kilometer</u>	<u>Per Passenger</u>	<u>Special Trip</u>
<u>1 KM (Minimum)</u>	<u>Php15.00</u>	<u>PhP30.00</u>
<u>2 KMS</u>	<u>Php17.00</u>	<u>PhP32.00</u>
<u>3 KMS</u>	<u>Php19.00</u>	<u>PhP34.00</u>
<u>4 KMS</u>	<u>Php24.00</u>	<u>PhP39.00</u>
<u>5 KMS</u>	<u>Php29.00</u>	<u>PhP44.00"</u>


Section 2. Separability. In case certain provisions of this Ordinance are declared void by a court of law, the provisions hereof not affected by the said judicial declaration shall continue to have legal force and effect.

Section 3. Effectivity. This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof. A copy of this Ordinance shall also be published once in a newspaper of general circulation in the Province of Cavite.


