AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION EIGHT HUNDRED SIXTY TWO THOUSAND PESOS (PHP 2,862,000.00) FROM THE "TRAVELING EXPENSES-LOCAL", "TRAINING EXPENSES", "TELEPHONE EXPENSES-LANDLINE", "TELEPHONE EXPENSES (MOBILE)", "JANITORIAL SERVICES (MANPOWER SERVICES)", "SECURITY SERVICES (SECURITY GUARD)", "INSURANCE EXPENSES (MOTOR VEHICLES)", AND "OTHER PROFESSIONAL SERVICES (PEST CONTROL)", TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "WATER EXPENSES" IN THE ANNUAL BUDGET OF THE GENERAL SERVICES OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2021.

BE IT ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :



Section 2. Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated:

Section 4. This Ordinance shall take effect ten (10) days from the date a copy hereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.
