AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP 2,500,000.00) FROM THE "DONATIONS (LGU HOSPITALIZATION PROGRAM)", TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "DONATIONS (PAUPER'S BURIAL ASSISTANCE)" IN THE ANNUAL BUDGET OF THE OFFICE OF THE MAYOR (VARIOUS LOCAL GOVERNMENT AFFAIRS), CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2021.

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above stated.


