APPROPRIATION ORDINANCE NO. 190-2021

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 5, SERIES OF 2021 INVOLVING SEVEN MILLION THREE HUNDRED THIRTY-FIVE THOUSAND PESOS (PHP 7,335,000.00) FOR PAYMENT OF THE GRATUITY PAY OF JOB ORDER AND CONTRACT OF SERVICES WORKERS OF THE CITY GOVERNMENT OF BACOR FOR FISCAL YEAR 2021 PURSUANT TO ADMINISTRATIVE ORDER NO. 46.

Section 1.
