CITY ORDINANCE NO. 2022 -209
Series of 2022

AN ORDINANCE CREATING THE TRICYCLE FRANCHISING REGULATORY UNIT UNDER THE BACoor TRAFFIC MANAGEMENT DEPARTMENT.

WHEREAS, the Tricycle Franchising Regulatory Unit (TFRU) was once a unit under the Bacoor Traffic Management Department and was tasked primarily to regulate the grant and renewal of franchises for public utility tricycles (PUTs) in the City of Bacoor, Cavite.

WHEREAS, in order to better improve the process of granting franchises to PUT's and give the commuting public a voice in the franchising process, the TFRU was abolished by virtue of City Ordinance No. 2013-047 and its powers and functions were transferred to the Bacoor City Transportation and Franchising Board (BCTFB).

WHEREAS, a review of the performance of the BCTFB conducted by the Sangguniang Panlungsod revealed that it failed to deliver the level of public service expected from it. Thus, the Sanggunian passed City Ordinance No. 11-2019 which led to the abolition of the BCTFB. The power to grant and renew franchises for PUTs was reposed in the Sanggunian and all the personnel, records, and equipment of the BCTFB was transferred to the BTMD.

WHEREAS, a review of the performance of the BTMD revealed that it has retained the institutional expertise to review applications for PUT franchises and that the said asset can be utilized in advising the members of the Sanggunian in granting franchise applications. However, there is a need to re-establish the TFRU and place the same under the BTMD to avoid public confusion, enhance operational efficiency, and ensure the delivery of quality public service.

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. Creation of the Tricycle Franchising Regulatory Unit. The Tricycle Franchising Regulatory Unit (TFRU) is hereby created. It shall form part of the Traffic Engineering and Planning Unit of the BTMD and shall be headed by the Head of the BTMD under the direct control and supervision of the City Mayor.

Section 2. Powers and Duties of the TFRU. The TFRU shall have the following powers and duties:

2.1. Make its internal rules of procedure subject to the approval of the City Mayor of the City of Bacoor, Cavite;

2.2. Endorse applications for accreditation of transport organizations to the Sangguniang Panlungsod for approval;

2.3. Set qualifications, fees and/or conditions, for the grant of a new/renewed application for franchise to operate any PUV within the territorial jurisdiction of the City of Bacoor;

2.4. Revoke the franchise it issued to any PUT exclusively operating within the City of Bacoor for violation of the provisions of this Ordinance or any related ordinance passed by the Sangguniang Panlungsod or by the national legislature, or any of the rules and/or guidelines it passed;

2.5. Determine and/or adjust the standard transport fare to be imposed by operators of PUTs operating exclusively within the City of Bacoor on the riding public, subject to the approval of the Sangguniang Panlungsod;

2.6. Determine the location, construction and operation of transport terminals for all public utility vehicles (PUVs) operating within the City of Bacoor, the terminal fees to be imposed by the tricycle operators and drivers associations (TODAs) on their respective members, the manner of operation of the said terminals, and the guidelines for passengers using the said terminals;

2.7. Recommend the closure of any terminal violating this Ordinance or any of rules and/or guidelines of the TRFU to the City Mayor;

2.8. Determine the routes to be used by PUTs operating within the City of Bacoor subject to the written approval of the City Mayor;

2.9. Take cognizance and act on complaints filed by individuals or transport organizations concerning or relating to franchise, terminals, fares and routes; and

2.10. Exercise any other power that may be granted to it by means of an ordinance.

Section 3. Oversight Powers of the Sangguniang Panlungsod. Considering that the power to regulate the operation of PUTs has been granted by law to the Sangguniang Panlungsod, it shall retain its oversight powers over the TFRU and shall have the power to disapprove any franchise granted by the said unit that violates this Ordinance or any other related city ordinances.

Section 4. Consultants. The City Mayor shall engage the services of the following persons as consultants of the TFRU:

- The presidents of the federation of Tricycle Operators and Drivers Association for the District 1 and 2 of the City of Bacoor, Cavite; and
- The presidents of the federation of Pedicab Operators and Drivers Association for the District 1 and 2 of the City of Bacoor, Cavite.

The salary of the said consultants shall be determined by the City Mayor based on existing government regulation with regard the hiring of such consultants. The said consultants shall advise the City Mayor and the Sangguniang Panlungsod on applications for franchise covered by this Ordinance.

Section 5. Implementing Guidelines. The BTMD shall formulate the internal rules of procedures of the TFRU within thirty (30) calendar days from the date of effectivity of this Ordinance. The said guidelines shall be subject to the approval of the City Mayor before it can be implemented.

Section 6. Repeal. All ordinances, resolutions and executive orders inconsistent with the provisions of this Ordinance are repealed.


