AN ORDINANCE ABOLISHING CERTAIN POSITIONS IN THE PLANTILLA OF THE OFFICE OF THE VICE MAYOR AND CREATING VARIOUS POSITION UNDER THE OFFICE OF THE CITY MAYOR, THE CITY ENGINEERING OFFICE, AND THE OFFICE OF THE SANGGUNIANG PANLUNGSOD FOR FISCAL YEAR 2022.

WHEREAS, Section 11, (viii) of Republic Act No.10160 (the "Charter of the City of Bacoor, Cavite") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects and services and activities of the city government.

WHEREAS, on 29 July 2022, City Mayor Strike B. Revilla wrote the Sanggunian and requested the creation of various positions under his office and under the City Engineering Office to improve the rendition of public service by the said offices.

WHEREAS, City Vice Mayor Rowena Bautista-Mendiola evaluated the present plantilla of her office. She informed the Sanggunian that there is a need to abolish some positions in the plantilla of the OVM that remained unfilled since they were created and use the funds appropriated for the said positions to finance new positions to be created under the Office of the Sangguniang Panlungsod.

WHEREAS, the Committee on Ethics, Appointments, and Government Re-organization conducted a hearing on the said requests and recommended the immediate approval thereof.


Section 8. Separability. The various provisions of this Ordinance not affected by a judicial declaration invalidating certain provisions hereof shall remain valid.
