AN ORDINANCE ABOLISHING CERTAIN POSITIONS IN THE PLANTILLA OF THE ZONING AND LAND DEVELOPMENT DEPARTMENT OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE AND CREATING VARIOUS POSITIONS UNDER THE SAME DEPARTMENT FOR FISCAL YEAR 2022.

WHEREAS, Section 11. (viii) Republic Act No. 10160 (the "Charter City of Bacoor, Cavite") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government.

WHEREAS, the Office the City Mayor sent a letter request to the Sangguniang Panlungsod for the abolition of certain positions under the Zoning and Land Development Department and the creation of various positions under the same office.

WHEREAS, the said abolition and creation of office positions will greatly aid the said department in the efficient delivery of basic services to the public.

BE IT ORDAINED by the Sangguniang Panlungsod in Regular Session assembled THAT:
