Section 1. The amended Integrated Zoning Ordinance of the City of Bacoor is hereby unanimously enacted. A copy of said ordinance is attached hereto as **Annex "A"**.

Section 3. The said ordinance shall take effect immediately after its publication in a newspaper of general circulation and after its posting for a minimum period of three (3) consecutive weeks at prominent places in the city.

Section 4. Let copies of the said ordinance be sent to the Office of the City Mayor and to all the concerned departments of the local government of the City of Bacoor, Cavite.
