CITY ORDINANCE NO. 223-2022

AN ORDINANCE CREATING CERTAIN POSITIONS IN THE PLANTILLA OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE FOR FISCAL YEAR 2022.

WHEREAS, Section 11, (viii) of Republic Act No. 10160 (the "Charter City of Bacoor, Cavite") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government.

WHEREAS, the Office the City Mayor sent a letter request to the Sangguniang Panlungsod for the approval of an ordinance creating various positions under the plantilla of the City Social Welfare Development Office (CSWDO).

WHEREAS, the creation of the said positions will greatly aid the said department in the efficient delivery of basic services to the public.

BE IT ORDAINED by the 5th Sangguniang Panlungsod in Regular Session assembled THAT:

Section 1. Creation of Positions and Funding. The following positions in the plantilla of the City Social Welfare and Development Office - the salaries of which shall be appropriated

Section 2. Date of Effectivity. -- This Ordinance shall take effect immediately after it has been published once in a newspaper of general circulation in the City of Bacoor, Cavite.

Section 3. Separability. -- Any provision of this Ordinance not declared void by any court of law shall remain valid.

Section 4. Dissemination. The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Civil Service Commission, the Human Resources Development and Management Department, the City Social Welfare and Development Office, the Office of the City Budget Officer, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all government offices concerned with copies of this Ordinance.
