CITY ORDINANCE NO. 226-2022
Series of 2022

AN ORDINANCE REGULATING THE USE OF, AND ACCESS TO, THE RIVER DRIVE ROAD WITHIN THE CITY OF BACOOR, CAVITE AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

Section 1. Title. This ordinance shall be known as the "River Drive Use Access Ordinance".

Section 2. The River Drive Road. For purposes of this Ordinance, the River Drive Road shall refer to the 1.61 kilometer-long road stretching from Barangay Molino III to Barangay San Nicolas II within the territorial jurisdiction of the City of Bacoor, Cavite.

Section 3. Limitation in Access. The River Drive Road shall only be used by privately owned cars from 4:00 a.m. to 10:00 p.m. everyday with a valid Solidarity Route sticker. No public utility vehicle, bus, or truck regardless of engine displacement shall be allowed to use the said road.

Section 4. Road Blocks and Checkpoints. The City Government, through the Bacoor Traffic Management Department (BTMD) and the Bacoor City Police Station shall maintain road blocks and checkpoints on various areas along the River Drive Road to ensure the implementation of this Ordinance.

Section 5. Penalties. Any person who shall violate this Ordinance shall pay a fine of Php 2,500.00. Any appointed employee of the city government or of the various barangays of the City who violates this Ordinance shall be suspended for three (3) days without pay aside from paying the fine mentioned above.

Section 6. Repeal. All ordinances, resolutions, and executive orders inconsistent with the provisions hereof are hereby repealed and modified.

Section 7. Automatic Review. This Ordinance shall be automatically reviewed by the Sangguniang Panlungsod once every three (3) years.

Section 8. Implementing Rules and Regulations. To appropriately manage the orderly administration of the provisions of this Ordinance, the BTMD and the City Legal Services Office shall prepare its Implementing Rules and Regulations for approval of the City Mayor within one (1) month from the date of effectivity of this Ordinance.

Section 9. Separability Clause. If for any reason, any portion or provision, section or part of the Code is declared not valid by a Court of competent jurisdiction or suspended or revoked by the Sanggunian, such judgment shall not affect or impair the remaining portions, provisions, sections, or parts hereof which shall remain or continue to be in full force and effect.

Section 10. Repealing Clause. All ordinances, rules and regulations or parts thereof which are in conflict or inconsistent with the provisions of this Ordinance are hereby considered repealed, amended or modified, accordingly.

Section 11. Date of Effectivity. This Ordinance shall take effect immediately after its publication at least once in a newspaper of general circulation in the Province of Cavite.
